



PROCEDURES FOR RECONSIDERATION OF MATERIALS

Any Acadia Parish Library cardholder may request that an item in the library's collections be reviewed for appropriateness. We value your opinion. Please complete this form indicating the nature of your concern. If your concerns relate to other library services, please indicate in the appropriate space.

The procedure for reconsideration of material is as follows:

1. The patron seeking reconsideration of a work receives a copy of the Acadia Parish Library Materials Selection Policy, the Library Bill of Rights and a Request for Reconsideration of Library Materials form. These are available at all circulation desks.
2. The patron seeking reconsideration must read, view, or listen to the entirety of the work before requesting reconsideration of library material.
3. The patron may submit the Request for Reconsideration of Material form at any Acadia Parish Library circulation desk. The patron will receive a letter acknowledging receipt of the Request for Reconsideration form by the library and advising that a written response to the Request will be sent within 28 days.
4. The form is routed to the Assistant Director who will assign a librarian to review and research the request. The librarian will present a recommendation to the Assistant Director, Library Director and Library Board President.
5. The librarian and Library Director will contact the patron to discuss the patron's request and the Library's decision regarding the material.
6. The Library's decision will be mailed within 28 days of the original request.

If the customer is not satisfied with the Library's decision, the customer may file a written notice of appeal within 30 days to the Library Director.

Request for Reconsideration of Library Materials

The Acadia Parish Library selects material with great care, using established criteria and giving full consideration to the varying age groups as well as differing education and cultural backgrounds of patrons the Library serves.

Patrons who would like the Library to reconsider a title's place in the collection are required to complete the attached form.

Library Bill of Rights

The American Library Association affirms that all libraries are forums for information and ideas, and that the following basic policies should guide their services.

- I. Books and other library resources should be provided for the interest, information, and enlightenment of all people of the community the library serves. Materials should not be excluded because of the origin, background, or views of those contributing to their creation.
- II. Libraries should provide materials and information presenting all points of view on current and historical issues. Materials should not be proscribed or removed because of partisan or doctrinal disapproval.
- III. Libraries should challenge censorship in the fulfillment of their responsibility to provide information and enlightenment.
- IV. Libraries should cooperate with all persons and groups concerned with resisting abridgment of free expression and free access to ideas.
- V. A person's right to use a library should not be denied or abridged because of origin, age, background, or views.
- VI. Libraries which make exhibit spaces and meeting rooms available to the public they serve should make such facilities available on an equitable basis, regardless of the beliefs or affiliations of individuals or groups requesting their use.
